

## Proxy Access Frequently Asked Questions (FAQ's)

### 1. What is a proxy?

A proxy is a person that is authorized by you the student to discuss all matters related to billing and financial aid with the Bursar and Financial Aid office staff at Fairfield University.

### 2. As a student, why do I need to assign a proxy to discuss matters of billing and financial aid on my behalf?

Often times, students rely on the support of their parents and others to assist them with financing their education at Fairfield University. In order to ensure that the matters are discussed with approved persons and in order for the University to ensure compliance with FERPA regulations, the offices of the Bursar and Financial Aid have created the proxy process.

### 3. What is FERPA?

The Family Rights and Privacy Act of 1974 (FERPA) provides for the confidentiality of student educational records. Fairfield University may not disclose information in a student's educational records to anyone without the permission of the student, unless disclosure is permitted by an exception set forth in FERPA, 20 U.S.C.A., Sec. 1232 et seq. By establishing a proxy and assigning that proxy a passphrase, you the student are granting permission to Fairfield University officials to disclose and/or discuss the contents of your billing and financial aid records, which includes account charges and balances, required financial aid documents, and financial aid awards to that proxy once the passphrase is validated by office staff.

### 4. What is a passphrase?

A passphrase is a word or a series of words (a phrase) assigned by the student for a proxy. The proxy will be required to provide the staff of the offices of the Bursar and Financial Aid with their assigned passphrase word or phrase in all correspondence or contact (in-person, written, or phone).

Example of passphrase words:

Kitten

Flower

Happy

Examples of passphrase phrases:

My favorite color is red

I love my dog

Porkchops and applesauce

### 5. Can a student establish more than one proxy?

Yes. The student will need to assign proxy access and establish a passphrase for each person that the student would like to authorize to discuss any matters concerning billing or financial aid.

6. Can a passphrase be the same for each proxy?

Yes. You may use the same passphrase word or phrase for each proxy that you assign or you may establish different passphrase words or phrases for each proxy.

7. What happens when a student establishes a proxy and a passphrase?

Once you establish a proxy, the proxy will be emailed a notification that proxy access has been established by the student. Once the student assigns a passphrase for the proxy, the proxy will receive an email with the passphrase.

8. What happens if the student forgets to assign a passphrase for the proxy to use?

The proxy will not be able to access Bursar and Financial Aid information without a passphrase. The proxy will be asked to contact the student and ask the student to assign a passphrase for use when contacting the offices of the Bursar and Financial Aid.

9. How long does a proxy have access to Bursar and Financial Aid records at Fairfield University?

A proxy will be granted access for 5 years from the date that the access is established.

10. Can proxy access be rescinded, cancelled or removed by the student?

Yes. A student may rescind, cancel or remove a proxy or a passphrase at any time by returning to the proxy access tab in Banner Self Service, selecting Proxy Management and expand the proxy to expire the proxy or remove the passphrase.

11. Can a new proxy be established at any time?

Yes. A student may establish a proxy at any time by returning to the proxy access tab in Banner Self Service, selecting Proxy Management and elect to add a proxy.

12. Can a student change the passphrase at any time?

Yes. A student may change or remove a passphrase assigned to a proxy at any time by returning to the proxy access tab in Banner Self Service, selecting Proxy Management and expand the proxy to change or remove the pass passphrase assigned to that proxy.

Changing a passphrase will continue to permit access to Bursar and Financial Aid records.

Removing a passphrase will rescind/cancel the proxy's access to Bursar and Financial Aid records.
